"It is important to remember that this past April, the Association Agreement with the countries in the region was ratified, positioning Central America as a strategic area for the European Union. We have a parliamentary term to, on one hand, strengthen economic, political, and social ties, and on the other, to reinforce both regions' commitment to sustainable development and respect for human rights."
