Foreword

In their 2009 European election campaign, the Greens promised a solution to the triple economic, social and environmental crisis Europe was facing: a Green New Deal for Europe.

European voters responded by making the Greens/EFA group a big winner of the election. As the European Parliament reduced in size from 785 to 736 members, the Greens/EFA Group was the only political group to grow: from 43 to 55 members.

4

These 55 Members – 29 women and 26 men – come from diverse backgrounds. They include members of Green movements, representatives of stateless nations and independent members.

From 2009-2014, it is the task of those elected members to tirelessly promote and vote for the measures that are necessary to deliver the Green New Deal. Action is required across the full scope of European policy and law-making to achieve an ambitious commitment to climate protection and a radical transformation of the economy to deliver millions of green jobs.

During this five-year term, Greens will also remain at the vanguard of efforts to promote respect for civil and human rights within and outside Europe, a responsible role for Europe on the world stage, as well as better democracy and accountability of the EU institutions.

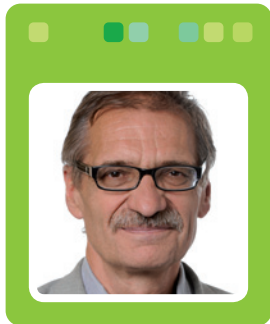

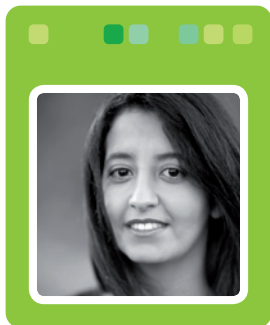

History of the group



A SHORT HISTORY OF THE GREENS IN THE EUROPEAN PARLIAMENT

1984

For the first time, Greens are elected to the European parliament. 7 MEPs from Germany, 2 from Belgium and 2 from the Netherlands. Together with non-Green MEPs from Italy, Denmark, and regionalists from Flanders and Ireland, they form the Rainbow group.

1989

Breakthrough in the European elections for the Greens throughout the European Community. Greens from France, Italy and Portugal join the Germans, Belgian and Dutch MEPs. They form the first green group counting 30 Members. The British Greens achieve a record result of 14,9 % but stay without any seat due to the British «first past the post» electoral system.

1994

Mixed results in the European elections. Whereas the German Greens score a record vote, French and Portuguese Greens lose all their seats. For the first time Greens from Luxembourg and from Ireland are elected. The group shrinks to 23 members.

1995

During a speech by French President Chirac, the Greens stage a spectacular protest in the plenary room against French nuclear tests on Mururoa.

The suicide of Alexander Langer, Co-President of the Green Group, shatters the Green group. Green MEPs from Austria, Finland and Sweden join the group which counts then 27 members.

1999

Very good results at the European elections, 38 Green MEPs get elected. Together with 10 MEPs from the European Free Alliance (regionalists and democratic nationalists) they form the Greens/EFA group, which becomes the fourth largest group in the European Parliament.

German Michaela Schreyer becomes the first Green Commissioner, responsible for budget and anti-fraud.

Heydays of Green political power: The Greens are in government in five out of 15 EU countries (Belgium, Finland, France, Germany, Italy), which gives their environment ministers a decisive clout on the negotiations on the Kyoto protocol.



2004

On 21 February the European Green Party is founded in Rome, which becomes the first political party to lead a common European elections campaign. In the June elections the Greens win 34 seats, but fail to win any seats in 10 new member states and renew their Alliance with EFA and take independent MEPs on board. The 42 member strong group remains the fourth largest group in the EU parliament

In the June elections, Greens are very successful and win 46 seats but again fail to win any seat in the 12 newest member states. By renewing their alliance with EFA and taking two independent MEPs on board, the group remains the fourth largest group in the EU parliament with 55 MEPs. Daniel Cohn-Bendit and Rebecca Harms are elected Co-Presidents of the group for the first half of the legislative period.

2007

The Czech Greens are the first Green party in the new member states to enter a coalition government.

The Greens/EFA group is overtaken by the right wing UEN group and becomes fifth largest group in the Parliament.

2009

On 27/28 March, at their Congress in Brussels, the European Green parties launch their second common European election campaign, present the election manifesto «A Green New Deal for Europe» and adopt a resolution «Stop Barroso».

Greens launch an institutional and political fight against the reconduction of José Manuel Barroso as head of the European Commission.
